High School Transcript or HiSET/GED Scores

Please submit any previous college transcripts for evaluation.

Test scores – Submit all ACT and/or Accuplacer NextGen test scores:

- Test scores are used for program admittance and course placement
- Test scores may be waived with approved transfer credit

ACT Test Scores

- Algebra: 18
- English: 18
- Reading: 18

OR Accuplacer - Next Gen

- Algebra: 241
- English: 251
- Reading: 250

TEAS Test Scores – A minimum composite score of 60 is required.

To schedule your test, go to statetechmo.edu/testing/. This test must be taken within five years of application submission and can be taken 3 times in an admissions cycle.

Total of 4 hours of documented Observation Experience with a Licensed Practical Nurse (LPN) or Registered Nurse (RN). The observation will not be accepted if completed at the applicant's current place of employment. Both forms, Applicant Initial Set-Up of Observation Form and Applicant Observation Form, need to be completed and submitted to the Office of Admissions.
