

Reporting date: March 31, 2022

1. On April 9, 2020, the Certification and Agreement were signed and returned to the Department of Education. State Technical College of Missouri will use no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students. The College's Higher Education Emergency Relief Funding was awarded on April 24, 2020. The College began awarding Higher Education Emergency Relief Funding on May 8, 2020 and all funds were disbursed as of May 27, 2020.

On January 19, 2021, State Technical College of Missouri received an additional \$682,090 in student aid funding to provide Emergency Financial Aid Grants to students. The College began awarding Higher Education Emergency Relief Funding on February 18, 2021 and all funds were disbursed as of March 31, 2021.

On May 16, 2021, State Technical College of Missouri received an additional \$1,961,087.00 in student aid funding to provide Emergency Financial Aid Grants to students. The College began awarding Higher Education Emergency Relief Funding on September 23, 2021 and all but \$2,104 of funds were disbursed as of March 31, 2022.

2. The total amount of funds that the institution will receive from the Department of Education for Emergency Financial Aid Grants to Students is \$3,325,267 ($\$682,090 + \$682,090 + \$1,961,087$).

3. As of September 30, 2021, the total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act is \$1,364,180.00 ($\$682,090 + \$682,090 + \$1,961,087$). As of March 31, 2022, \$2,104 in funds remained to be distributed to students.

4. The total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act is 1,216. These students received a survey to indicate they had a need for funding. As of September 30, 2021, the estimated total number of students at the institution eligible to participate in Emergency Financial

Aid Grants to students is 4,475 (1,216 + 1,453 + 1,806).

5. The total number of students that received grants is 3,887 (628 + 1,453 + 1,806). In some instances, multiple disbursements were issued.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act:

May 2020 - The State Technical College of Missouri CARES Act grant provided an opportunity to apply for an emergency one-time grant. Eligible students must be full-time Title IV eligible Pell students enrolled in the spring term. Eligible students had the ability to complete a survey weighting the percentage of distribution to each individual student. Only students enrolled full-time as of March 22, 2020 and eligible to receive Title IV aid based on implementation guidance provided by the U.S. Department of Education met the criteria to receive the survey. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

April 22, 2020 and April 30, 2020, students received e-mails explaining the process to receive the grant and the May 1, 2020 deadline to complete the survey.

February 2021 – The College compiled a list of all Full-Time and Part-Time Degree Seeking students with a FAFSA on file. The list included 1,454 unique students. Each student was provided a check in the amount of \$470.00.

September 2021 – The College compiled a list of all Full-Time and Part-Time Degree Seeking students. The list included 1,806 unique students. Pell eligible students received \$1,152.00 and all other students received \$1,052.00. Each student was provided a check in the amount of the award.
